### 1. Conflicts of Interest

- 1.1 You will disclose to Nunyara any interests (whether direct or indirect) which arise that may have the potential to undermine the impartiality of decision because of the possibility of a clash between the persons self interest and professional or public interest
- 1.2 You will not undertake any work for reward during the term of membership without the prior consent and endorsement of the Board

### 2. Membership

- 2.1 Individuals applying for full membership of the Association must do so in writing on the prescribed form providing evidence, where required, that they are eligible for membership under these Rules and under the Act.
- 2.2 All members must agree with and subscribe to the objects of the Association.
- 2.3 Applications for membership must be considered and endorsed by the Board and recorded in the minutes of the meeting.
- 2.4 Applications for membership can only be considered and endorsed up to three months before an Annual General Meeting. Applications for membership received during the three months prior to an Annual General Meeting shall be processed after the Annual General Meeting.
- 2.5 Applications for membership will not be considered from the floor during a general meeting.
- 2.6 The Board retains the discretionary right to not accept or endorse any application for membership.
- 2.7 All individuals applying for membership will receive written advice on the outcome of their application.
- 2.8 The Board retains the right to cap membership numbers at any time.
- 2.9 The Board retains the right to apply a membership fee at any time.

### 3. Types of membership

Full membership to the association is open to individuals who:

- 3.1 Subscribe to the objects of the Association
- 3.2 Are aged 18 years and over at the time of lodging a membership application, and Are of Aboriginal descent, and
- 3.3 Have been resident in Whyalla, South Australia for at least 1 year at the time of lodging a membership application and
- 3.4 Are currently residing in Whyalla, South Australia at the time of lodging a membership application.
- 3.5 Membership is not open to individuals who are currently employed by the Association.
- 3.6 Membership is not open to individuals whose employment with the Association ended as a result of work performance issues, disciplinary action, or any other

circumstances the Board deem controversial (including those who resigned as a result of such issues or action) within the 5 years preceding the date of their membership application.

3.7 Membership is not open to organisations.

#### 4. Confidential Information

4.1 Except as required by law, you must not disclose, divulge, communicate to or otherwise place at the disposal of any third party, in any form or by any means and must keep in the strictest confidence any Confidential Information of which you become aware through membership.

#### 5. Sensitive Information

4.1 Except as required by law, you must not disclose, divulge, communicate to or otherwise place at the disposal of any third party, in any form or by any means and must keep in the strictest confidence any Sensitive Information irrespective of whether or not that information is confidential in nature or in the public domain.

#### 6. Intellectual Property Rights
